

WE ARE DEEPLY COMMITTED TO THESE DOGS AND OUR EFFORTS ARE FOCUSED ON SUCCESSFULLY REHABILITATING OUR DOGS UNTIL THEY ARE READY TO GO TO A LOVING HOME.

OUR THIRD HIGHEST EXPENSE IS OUR ADOPTION AND FOSTER CARE PROGRAM. THESE PROGRAMS ARE MANAGED BY PAID STAFF, INCLUDING A DIRECTOR OF ADOPTION PROGRAMS, FOSTER CARE COORDINATOR AND ADOPTIONS MANAGER.

IF THEY APPEAR TO BE A GOOD MATCH, VETERINARY REFERENCES AND PHOTOS OF FENCED YARDS AND GATES ARE REQUESTED. HOME VISITS ARE SCHEDULED, IF DEEMED APPROPRIATE.

OVERCOMING THE BEHAVIORAL CHALLENGES OF SOME PUPPY MILL SURVIVORS IS NOT FOR EVERYONE, WHICH IS WHY OUR INTENSIVE ADOPTION PROCESS IS NECESSARY. OUR GOAL IS TO ENSURE THAT THROUGH OUR VERY BEST EFFORTS WE ARE SELECTING ONLY THE FINEST PERMANENT HOMES FOR OUR DOGS.
